MOTION TO AMMEND CARROLL REFUSE CONTRACT EFFECTIVE JULY 1, 2020

MAYOR REPORT Mayor Soseman reported she has been busy with COVID-19 issues since last week. Prior to that she had been attending meetings and working on Census. She applauds all dept. heads and council for their efforts and response with COVID-19 issues. She was on a conference call with Gov. Reynolds today and there are lots of things in the works. The CDC is working to keep local businesses viable and encouraging local retailers to remain open. Crawford reported that plans for Ave C/7th St have to include more CITY MANAGER REPORT sidewalks than originally thought per DOT and have to be resubmitted tomorrow for the June 16th letting. Bids are due Apr. 2nd for the Aquatic Center slide steps project with a completion date of May 15th. The FEMA project bids (flood damage Mar. 2019) are due Mar. 27th. The FAA want us to proceed with the small airport grant project of \$600,000 because they were not able to come up with all the discretionary funding for the complete project at this time so we will just do the next phase. Council gave consensus for Chief Schaffer to order the new Police Dept. vehicle. Council gave consensus for Catherine at Boulders Conference to proceed with the wedding on Mar. 28th since the family is limiting it to 18 people. There being no other business, the meeting adjourned at 5:32 p.m.
