DISCUSS ALLOWING WESCO OF BROADWAY & MAIN ST INTO OUTDOOR DINING AREA

MAYOR REPORT

Mayor Soseman reminded everyone to go online and fill out their Census forms if haven't done so. There is a housing board meeting tomorrow at noon. The Christmas decoration committee met last night and they are looking at the next phase of decorations. Midwestern College was in town last week and donated a bench in Washington Park. They also made donations to McHenry House & Donna Reed Theater. Mayor Soseman did a walk through of the uptown with Joni Ernest last week.

CITY MANAGER REPORT

Crawford reported that we will be having a street patching demo with a Durapatch machine on N. Main St. on Sept. 2nd. The Ave C/7th St project will begin Sept. 1st and should be complete before the end of October. The contract & bond will be approved for 20th St. at the next council meeting and can be completed right after Ave C/7th St. The Airport project is getting close to the seeding stage. There were some stop sign requests made and Terry will analyze them and report back. Council asked to have the stop signs put on the agenda for the Planning Session on Sept. 1st.
